

## CHC33021 Certificate III in Individual Support (Disability)



The qualification CHC33021 Certificate III in Individual Support (Disability) is intended for those who are currently working in Disability sector and wish to quickly gain professional recognition of their skills and knowledge, or alternatively those who wish to enter the profession with the necessary skills and knowledge to accept a professional level of responsibility.

The course consists of thirteen (15) units of competency comprising of a minimum of nine (9) core and, and six (6) elective units from the CHC Training Package (Release 8).

Qualitycare Training Institute has developed a program that meets the requirements of the qualification, as shown below. Alternative combinations of units of competency are possible within the rules of the training package; potential participants wishing to discuss alternative units should contact QualityCare Training Institute's office.

The qualification is nationally recognised and can only be delivered by a Registered Training Organisation (RTO) that complies with the governing standards of quality control and quality training and assessment.

Upon successful completion of the course assessments, you will be awarded a:

### CHC33021 Certificate III in Individual Support (Disability)

Participants who exit the training program without completing all assessments will be issued with a statement of attainment for those units in which they have demonstrated competency.

The qualification process also recognises your existing skills and knowledge. Recognition of Prior Learning (RPL) is a process where the participants existing skills and knowledge are matched against the

requirements of the qualification. If the participant is assessed as already having achieved competency the course is reduced in duration. Additional information on our RPL process is available from our Administration Office.

Participants in this job role are often required to physically assist people in their care, accordingly, participants need to be physically able. Participants with any concerns over their physical capability should contact QualityCare's Operations Manager.

Participants also need to be aware that an Australian Federal Police clearance is required before participants can participate in the clinical sessions, this clearance is also required for working in this industry.

The format for delivery/assessment is based on a six (6) weeks classroom training program comprising of two weekend sessions per week of 8 hrs duration, and 3 weeks of 40 hours per week in Clinical Placement. Initially the course will be delivered two sessions on Saturdays and Sundays. However, should demand indicate alternative delivery arrangements, these may be offered. Assessment will take place for each of the units studied at the end of each theory and clinical placement period.

To be eligible to enrol in our training programs participants must be able to read and write English to a sufficient standard to work with the supplied texts. A Language and Numeracy assessment will be delivered as part of the orientation program. Participants in our courses also need to be at least 18 years of age, proof of age will be required at time of enrolment.

**Fees and Charges:** The course fee is \$2,400, payable in two instalments and it includes all assessment booklets. A link to online study material will be provided for self-study of the topic prior to attending session on the topic.

Payment Schedule is:

\$1200.00 First deposit payment at the time of enrolment  
\$1200.00 During 5-6 week of classes (before Clinical Placements)

**(Or \$600 additional for those who are already enrolled in 'Ageing' stream of the certificate III  
Classes (our base course) for three additional disability units, Disability option, will be held during  
normal cycle of Ageing stream course but on different days.)**

**Due to the "progress payment" schedule for our courses, Qualitycare Training Institute does not offer any refunds.**
